- IV. Officer Reports
  - A. President
    - 1. Received a thank you letter from Sacramento Valley Conservancy.
    - 2. The Central Valley Bird Club symposium will be held in person this year. More information should be forthcoming.

  - A. SAS email options
    - 1. Background: As of April 23, all blind email addresses stop working. As an immediate work around, the blind emails were removed from the website. Personal and SAS gmail accounts were substituted.

- A. Chalk It Up 2022

- B. Birdability Sponsorship New Jersey World Series of Birding
  - 1. Birdability is raising money to send representative to the World Series of Birding in New Jersey.
  - 2. Birdability has been instrumental in helping SAS set-up our Accessible Birding Program. Raising awareness on a National Level, raises awareness locally.
  - 3. Motion to contribute \$500 to the Birdability World Series of Birding. (Paul 1<sup>st</sup>, Jane 2<sup>nd</sup>) Approved unanimously.
- C. Effie Yeaw Nature Center Grant Request
  - 1. Effie Yeaw Nature Center has submitted a grant request for \$1500. These funds will be used to purchase new field guides, binoculars, and monoculars.
  - 2. Motion to approve the grant of \$1500 for Effie Yeaw Nature Center for the purchase of new field guides, binoculars, and monoculars. (Nancy 1<sup>st</sup>, Paul 2<sup>nd</sup>) Approved unanimously.
- D. Field Activities Committee Mission and Protocols
  - 1. The Field Activities Committee has additional changes to make to these documents, request that the board review at a later date.
  - 2. Recommendation to rework the following sentence with stronger language indicating that any informal trip announced on the SAS Facebook page by an approved trip leader is "an officially sanctioned SAS field trip."

In addition to these formally scheduled trips, field trip leaders who are on the approved trip leaders list are welcome to announce informal trips on the SAS Facebook page.

3. Field Activities is looking for a volunteer to actively monitor the SAS Facebook group for any informal trips. This monitor would confirm that any informal trips announced are being offered by an approved leader and remove any field trips offered by a non-approved leader. Nancy is willing to be the monitor.

## VII. Committee Chair and Board Member Reports

- A. Membership Numbers from Jane's email to the Board on April 13, 2022.
  - 1. There are currently 682 dues-paying SAS Members. 409 of these are receiving enewsletters. There were 9 new SAS members this month and 4 previously inactive members sent in dues. 12 SAS members were made inactive this month (1 member moved away, 2 passed away, and 9 had not paid their dues)
  - 2. There are 2,749 NAS members that live in our chapter area. There were 14 new NAS members this month that live in our chapter area.

- C. Website: Primarily working on the changing structure of field trips.
