- III. Presentations: Converting St. Joseph Cemetery to a Memorial Tree and Garden Project Proposal, presented by Doug Bojack
 - A. Concept is to use native wildflowers, native trees to create habitat for native fauna and flora. Focusing specifically on native insect and bird habitat over the 12-acres of the Cemetery. It will use a Memorial Tree and Wildfower approach in which donor support creates an endowment for implementation and maintenance. Committed partners to the project include the Sacramento Tree Foundation, California Native Plant Society, Sierra Curtis Neighborhood Association, and Miridae Landscape Architecture Firm. Currently, in the process of gathering partners and refining the project. Hoping to establish partner roles and begin design process in the Spring of 2022. The Catholic Funeral and Cemetery Services is the entity which is responsible for St. Joseph's Cemetery. They are on board with the project and the idea of the cemetery as a living cemetery that is more integrated into the community. Asking from Sacramento Audubon to help with finding volunteers and promoting the project. At this time, do not see the need for a monetary commitment. Looking to January for a meeting with all committed partners and the church to detail how much of the property will be included in the project.
