IV. Officer Reports

A. President

- 1. The Public Accountability for Our Capitol group is requesting Sacramento Audubon's support in advocating against the Capitol Annex Project. Bill will send the email to board members for their review.
- 2. Bobelaine: Construction should be completed in late November. All signs on the property and notices on the website have been updated.

B. Treasurer

- 1. Membership revenue is up from this time last year. Additionally, we are not spending what we normally would be due to COVID-19.
- 2. Insurance
 - a. Changing from multiple bills each year to one bill per year. Currently, we have paid through July 2021. Our yearly bill is \$6,000.
 - b. Sacramento Audubon current coverage includes liability insurance, director's and officer's insurance, group and accident insurance, and employment insurance.
 - c. Harriet inquired if a trip leader is not a member, are they covered? According to our insurance provider, it does not make any difference. They are covered as a "volunteer."

C. Corresponding Secretary

- 1. Recommending the use Thank You postcards as opposed to Thank You letters.
 - a. Amount of time spent on Thank You letters seems out of proportion to the donation amount and expectation of the donors.
 - b. Heather presented two sample post cards. The first has a full picture on front and address and thank you on back. The other has a half picture and thank you on front, address on the back. All of the text would be preprinted except for the

- amount and address. Harriet recommended including the tax ID and language indicating we are a 501c.
- c. Concerns expressed from Board Members about including a donation amount on postcards where anyone could see the amount. Questions raised as to whether the amount needs to be included in the thank you and what this would mean for those who retain the letter for tax purposes.
- d. Heather will research the tax question and we will revisit at the November Board Meeting.

1. Proposal: Article II, Section 1: Remove the Past President from list of board members. Changing the sentence,

The Board shall include: (a) five elected Officers, (b) the immediate past president, (c) and five (5) elected Directors.

The Board shall include: (a) five elected Officers, (b) and six (6) elected Directors.

 The board recommends clarifying in the policies and procedures the role of the past president as an advisory non-voting position with no set term limit. If a past president wishes to remain as a voting member of the Board, they may rejoin as one of the elected Directors.

 - 2. Previous calendars have included a list of Outreach Events. Bill will put together a list of virtual events to be included on the calendar.
- B. Motion to purchase 5 copies of *Life Under the Fast Lane* and distribute them to the City of Sacramento at a cost of \$150 plus tax. (Elliot, Diana 2nd), passed unanimously.
 - 1. Ask Dan Airola to distribute the books to the appropriate people he has identified.
 - 2. Include a sticker in the front of each book, "Donated by the Sacramento Audubon Society." Elliot will provide the sticker.

VII. Committee Chair and Board Member Reports

- A. Membership (Jane)
 - 1. Motion to register for the 2021 Big Day of Giving (Diana, Harriet 2nd), passed unanimously.
 - 2. This month was a slow month for membership renewals, only 15 members. Other months we have many more. We are maintaining our membership levels with over 600 current members.

 - a. After talking with Habitat 2020, they recommend waiting until we know more before expending additional effort to involve ourselves in the Elk Grove CNU Hospital project.

- 1. CBCs Canceled?
 - a. A member contacted Elliot with concerns over the CBC being cancelled as was published in the October *Observer*.
 - b. On the SAS website it says most compliers will be deciding on Nov. 15 or later whether they will be holding their CBCs. It also states that the Woodford count is canceled this year due to COVID.
 - c. The Education Committee decide to publish the information that counts were cancelled to reduce the number of people asking to participate. If CBCs happen, they will be done with fewer people, contact directly by the compliers.
 - d. In the November *Observer*, a longer article will be published suggesting that CBCs, if they happen, will look a lot different this year. It will also recommend how individuals can participate on their own.
